He currently is Treasurer of Alexandria Neighborhood Health Services, Inc., a Federally Qualified Health Center. He has an MBA in finance from Vanderbilt University and a BA in economics from Davidson College.

Michael Bilton, MPP, Vice President, co-founded and led the Association for Community Health Improvement, a personal membership group of the American Hospital Association (AHA).
